

## Application for the authorisation of a congregational worship leader

1. Congregational Worship Leaders are authorised to lead Morning or Evening Prayer or services which comply with the Common Worship provisions of a Service of the Word. They are not authorised to preach or to preside at pastoral offices, however sermons or homilies prepared by or approved by the incumbent may be read.

2. Congregational Worship Leaders are not authorised to conduct funerals. An exception is made for those who have been authorised to do so by the Archdeacon prior to 31 December 2014 and who have completed the Diocesan Funeral Ministry Training.

3. The incumbent completes this application form. The Churchwardens must also sign the form. When completed, the application is to be sent to the archdeacon. The incumbent should keep a copy of the application until the permission has been received from the archdeacon.

4. The archdeacon will keep a copy of the application and permission with his records and forward a copy of both to the diocesan office for recording on the database.

5. The archdeacon will forward the signed permission to the incumbent.

6. The signed permission should be kept in the church safe or other secure place.

7. This form of application is to be used only for persons who are baptised and confirmed members of the Church of England or a Church in full communion therewith. If the proposed Congregational Worship leader is baptised but not a confirmed member of the Church of England or a Church in full communion therewith, the individual must complete the supplementary declaration.

8. Safeguarding procedures must be completed by the congregational worship leader. This includes the Confidential Declaration Form and a DBS check if the applicant has lived in the UK, and/or the equivalent Police Certificate and Certificate confirming non conviction record for countries outside the UK where the applicant is living or has lived for a period of 6 months or more from the age of 16.
